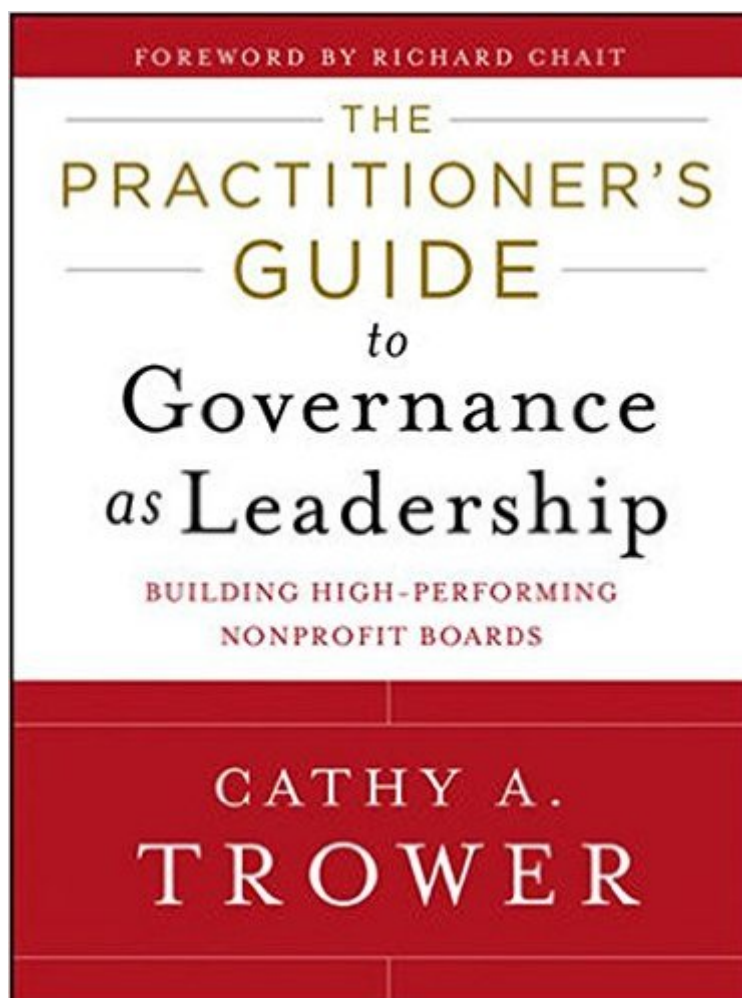

Not only does Trower do an excellent job of making complex ideas digestible, she has research and case studies that further explicate the many facets of Governance as Leadership. I particularly like the chart that explains the distinctions between the three modes, as well as the detail given to generative thinking. I find that many boards struggle with elevating the discourse and asking strategic questions.
